1. In September 1998, the U.S. Environmental Protection Agency (EPA) established the Consumer Confidence Report (CCR) Rule requiring community water systems to deliver an annual water quality report to their customers by July 1st of each year. Naval Facilities Engineering Systems Command, Hawaii is pleased to announce the availability of this year's Water Quality Report for the Joint Base Pearl Harbor–Hickam (JBPHH) water system and the Naval Computer Telecommunications Area Master Station Pacific (NCTAMS PAC) water system.

2. Under the CCR Rule, we are required to provide copies of the water quality report to all billing units or service connections to which water is delivered. In order to reach all customers, we request a copy of this letter with the links to the water quality reports be forwarded to the appropriate branch/division or personnel associated with your office that receive water from our system. For managing or contracting offices, you are also responsible for providing a copy of the report to each contractor under your cognizance. Please post this letter with a copy of the report in a conspicuous location(s) for all personnel and occupants of the building or facility to view.
